Kristen is a Licensed Independent Social Worker Supervisor (LISW-S) through the State of Ohio Counselor and Social Worker Board, graduating from The Ohio State University and the University of South Carolina with her BSSW and MSW in 2004, respectively. She is a Level II EMDR trained psychotherapist through EMDRIA with much advanced and master class training in somatic psychotherapy and reparative attachment, and is a Certified Hypnotherapist with American Society of Clinical Hypnosis, a Certified Trauma Specialist with the National Institute for Trauma and Loss in Children, as well as being trained in TF-CBT, CISM and several other therapeutic modalities. Kristen has served as the Clinical Director of Camp Lionheart for 12 years, Central Ohio's week-long, overnight grief camp for children and teens in the Hocking Hills, and continues to grow this program each year. Kristen frequently provides psychoeducation at conferences, schools and symposiums on topics such as traumatic grief, complex trauma, adoption issues and attachment. She lives in downtown Columbus, Ohio with her husband and their portly cat.

The overemphasis on school policies and practices in schools has led to an increasing number of children who become involved in the juvenile and criminal justice systems. Given the growth of youth incarcerated, there is a need to address school discipline and intervention strategies to decrease drop-out rates and improve access to positive career and higher educational opportunities. Research shows the cradle/school to prison pipeline disproportionately impacts students based on their race, ethnicity, socio-economic status and disability. Please join us for a discussion on the impacts the cradle/school to prison pipeline has on youths and our communities and how you can advocate for positive change.
