The purpose of this All County Letter (ACL) is to provide the adjusted schedules of rates that reflect the California Necessities Index (CNI) increase of 6.63 percent for fiscal year (FY) 2022-23 effective July 1, 2022. The CNI increase is applicable to out of home placements and the Aid to Families with Dependent Children-Foster Care (AFDC-FC) program.

placements and the Aid to Families with Dependant Children-Foster Care (AFDC-FC) program. All new rates are reflected in Attachment A.

COVID-19 STATIC CRITERIA

The <u>ACL 21-17</u> disseminated a reminder that COVID-19 has been added to the Static Criteria list of chronic indicators. The California Department of Social Services (CDSS) would like to clarify that COVID-19 as Static Criteria is permanent, can be **used anytime during a placement**, and is ongoing past December 31, 2021, when the temporary authorization of higher rates for placements impacted by COVID-19 ended per <u>ACL 22-05</u>.

The COVID-19 Static Rate may be paid whenever the child/youth has contracted COVID-19, tests positive, and/or is displaying continuing illness and/or side effects of COVID-19 and requires additional care and supervison for the duration of their illness. Documentation such as a positive COVID-19 test or a letter from a physician is sufficient to obtain the Static Rate.

Existing Static Criteria/Static Rate timeframes still apply wherein the child/youth can receive the Static Rate for COVID-19 up to 60 days, with an additional 60 days (not to exceed 120), upon approval. This policy only applies to a child/youth contracting COVID-19 and does not include another member of the household.

APPROVED RELATIVE CAREGIVER (ARC)

In accordance with <u>WIC section 11461.3</u>, and <u>SB 354 (Chapter 687, Statutes of 2021)</u> a relative caregiver is now eligible to receive ARC payments, if the placement is authorized by the juvenile court and the relative has been denied approval as a resource family (RF). There will be no new aid codes affiliated with this change, and counties are asked to continue using existing ARC aid codes in accordance with current practice. Please refer to ACL 22-33 for further information.

TRANSITIONAL HOUSING PLACEMENT NONMINOR DEPENDENT (THP-NMD)

The <u>ACL 20-121</u> notified counties and interested parties about the establishment of a THP-NMD Housing Supplement based on Fair Market Rent per county. Counties are reminded that the CNI is applied to the THP-NMD rate only and does not apply to the Housing Supplement. The THP-NMD Housing Supplement is being implemented on a phased-in basis across the state, available in CalWORKs Information Network counties on July 1, 2021, and in remaining California Statewide Automated Welfare System counties by September 1, 2022, contingent upon completion of the necessary

automation changes. The THP-NMD Housing Supplement rates are displayed below in Attachment A.

INNOVATIVE MODEL OF CARE (IMC)

In addition to administering the statewide rates described in this ACL, with the passage of <u>AB 2944</u>, the CDSS has the authority to approve alternative funding models and set individualized rates that are consistent with statewide licensing and program requirements. The <u>ACL 22-21</u> disseminated information regarding the new rate setting process for IMC rates and, as a reminder, rates approved under <u>AB 2944</u> will not be adjusted annually to reflect the CNI. The amount of an IMC rate may exceed the CDSS statewide rates, on the condition that the county pays the entire non-federal share of any additional cost that exceeds the non-federal portion of the statewide system of rates for existing AFDC-FC programs.

ADOPTION ASSISTANCE PROGRAM (AAP)

A separate ACL will be issued specific to AAP providing a comprehensive schedule of rates related to AAP and CNI increases, effective July 1, 2022.

SPECIALIZED CARE INCREMENT (SCI)

As a reminder, all SCIs are entirely for the RF thus, any Foster Family Agency (FFA) receiving a SCI on behalf of a child/youth placed in one of their homes shall forward the entire SCI to the RF.
