#### Description of Bid

This concession will be a restaurant and general store operation within one or more of the following State Parks: Beavers Bend, Roman Nose, Quartz Mountain, Sequoyah, Lake Murray, and Robbers Cave. The concession operator will provide restaurant food services, grocery store services, selected gift items, and other related services. The concession will be required to be open a minimum number of hours as required by the Department. The operating location will be in the State-owned restaurants in one or more State Parks. An existing building with equipment is available for use for this operation for all locations. A percentage of gross revenues will be paid to the park.

The initial term of this lease agreement will be for five (5) years with an additional five (5) year renewal option, upon the operation being acceptable to the state.

Liability insurance will be required. General provisions of the concession lease agreement are noted in the attached example Lease Agreement.

#### I. COMMISSION:

#### **II. DESCRIPTION:**

This concession will be restaurant and grocery store operation within the Restaurant area of one or more of the following Oklahoma State Parks: Beavers Bend, Roman Nose, Quartz Mountain, Sequoyah, Lake Murray, and Robbers Cave. The concession will be required to be open a minimum number of hours as required by the State, during the summer season and shoulder seasons.

In addition to food service, the concession may offer other appropriate resale items and services as approved by the State.

#### III. TERM

The initial term of this lease agreement will be for five (5) years with an additional five (5) year renewal option based upon the concession being acceptable to the State. The Oklahoma Tourism and Recreation Department shall have the right to grant or deny additional years at its sole discretion. Any extensions after the initial term of the contract will be at the sole discretion of the Oklahoma Tourism and Recreation Department.

#### IV. FINANCIAL STATEMENT:

Each bidder must submit a personal financial statement. The State must be able to verify the prospective lessee has the financial capability to carry out his/her operational plan as well as afford daily operating expenses.

#### V. OPERATIONAL PLAN:

Each bidder must propose and submit an operational plan that includes services and facilities to be offered. Each operational plan must specify the location or locations that they are bidding on.

Each proposal must include:

- MARKETING PLAN
- COMPANY INFORMATION

#### VI. BUSINESS PLAN

- PROJECTED REVENUE VS EXPENSES
- FINANCING PLAN
