Dear Ms. Born,

First, we just want to thank you for your years of service. Many of us that work for the city were saddened to hear that you will no longer be on council. We know that the administration was not always so kind to you and we recognize that those women were and are threatened by you. They know you will work hard to get to the truth regardless of their attempts to quiet you and you will be missed by many for that reason among many others.

There is a name that floats around for the three women over there and they've earned their title. They are dishonest and completely untrustworthy. They are only interested in protecting themselves and have no loyalty to the employees of this city or its residents. We feel bullied into silence and have reason to fear retaliation if we were to fight back or stand up for each other. Many of us not only work here, we live here too. We love this city and it's a shame that three women can ruin a place we were so proud of.

The three of them plot and scheme together and we have no doubt that they had something to do with you not winning your reelection. And that's the final straw. We are tired of working for a place where the administration can do as they please without any regard for the rest of the employees or the residents of this city.

So, we want to ask for your help. You're the only one we can trust to stand up for what's right. We want to inform you of some of the corruption and ask you to do a public records request and to share the information where you feel it's needed to address the corruption. We worry that if the wrong individual is informed they will act to cover it up. Bridgette Kabat keeps those around her close. Not for their work ethic or abilities but so they are always loyal to her. This city is totally controlled by her and Kate Sandretto and Kelly Chalfant will protect her at all costs, regardless of the price. So here are the issues we are ALL aware of but unable to address:

1. Kelly Chalfant works on her photography business on the city's dime.....constantly. She has the software to edit her photographs on her work computer and does many hours of editing during work hours. Both **Bridgette and Kate are aware of her crime** and have done nothing to address it!
 - a. She's not working on even personal stuff, she's working on projects from a LLC business where she generates income!!!! On the city's equipment and on the city's time. **Sounds like theft from office to us!**
 - b. And all that's needed is a public records request of what programs are on her computer and when they are used. All of that should be easily accessible to the IT department.
 - c. Not only is it a theft it's a double standard. They want us to feel put in our places while they can do whatever they please. We have been scolded for minor infractions of how we use our time and we clock in and out so every minute is monitored to ensure we aren't "stealing" time from the city....all while she makes money from it and Bridgette and Kate go in her office and look at her photos and support her theft from city.
 - d. Recently a number of us had our lunch hours reduced and were told that it was always supposed to be 30 mins. Is that because those three administrators are incompetent at their jobs or because they were trying to punish us to keep us in our lane? They work hard to create fear.
2. Bridgette Kabat should be fired for her choice to allow an employee to do what Kelly Chalfant has been doing for **YEARS!**
 - a. But she should also be investigated for her role in FrontPath's Board. How much did that cost the hard working tax payers of this city? Why aren't we investigating her

role and how it affected our insurance costs? From what we've read that case was **basically criminal** and the State's Auditor is now asking for the names of those board members. We can volunteer one name.....Bridgette Kabat! She doesn't care about this city. She doesn't live here and she refuses to even be a friend to any of the city employees.

- b. She should also be asked about her husband's employer and their contract with city supplies. Is there a contract? When did that start? And is her husband benefiting from her role as administrator? That seems pretty **unethical!** And we feel those questions could be answered by another records request.
3. Katheryn Sandretto- while she hasn't been here long she has made herself know to everyone in treating us all like dirt. We always hear she "basically runs the city". Who gave her POWER? Her only job seems to be agreeing with whatever the other two tell her, no matter if it's right or wrong. That sounds like the opposite role of a law director.
 - a. We would like you to ask Lucas County how they feel about her. Many of us have heard that she was pushed out for a reason. **What is she hiding and why is she being protected?**
 - b. From what we hear she's not even good at her job and we all definitely notice that she's rarely here, while we are sure to clock in and clock out. **How is that okay?**

So again we are grateful for your years of service and we are hopeful that your love for this city will be the reason you help its employees. We are more than suspicious as to how you were voted out and we hope if those three are outed for their corruption we will get you back and you can help us get this city back on track. **We need you!!!!!!!**
