- Implement a long-term drinking water monitoring plan.
- Conduct comprehensive infrastructure assessments and improvements of the JBPHH Drinking Water System.

What are the defueling requirements in the 2023 Consent Order?

Pursuant to Defueling Plan Supplement 2, the Navy

and DLA will follow an EPA approved defueling schedule to:1. Participate in emergency spill drills and have

- updated spill response plans in place prior to defueling,Perform necessary repairs and have a third party
 - verify repairs prior to defueling,
- 3. Drain the Red Hill tanks,
- 4. Defuel flowable tank bottoms,5. Unpack (remove the fuel from) the Red Hill
- pipelines, and

 6. Relocate the fuel to various locations.
- Another defueling plan supplement will be required to require removal of any residual fuel remaining in

to require removal of any residual fuel remaining in the system.

What are the closure requirements in the 2023 Consent Order?

The 2023 Consent Order identifies two phases for closure. For Phase 1 Closure, Navy and DLA shall submit interim closure reports within 30 days of when one or more of the 20 USTs, pipelines or surge tanks are closed. Phase 2 Closure may be addressed under the 2023 Consent Order or by the 2015 Red Hill Administrative Order on Consent or another EPA-

approved enforcement instrument.

What major changes occurred in the 2023 Consent Order after the public comment period?

- Formation of a Community Representation Initiative.

- Enhanced public involvement in decisions relating to defueling and closure of the Red Hill
- A commitment to seek additional input from subject matter experts including the Honolulu Board of Water Supply.
- Acknowledgment of the cultural significance of water to Native Hawaiians and Hawai'i residents and a commitment to seek local input into the decision-making process.
- Additional spill reporting requirements to ensure Navy and DLA report any spill that may present an immediate threat to human health or the environment to the Community Representation Initiative and the public via posting on the Navy's website within 24 hours.
