5 **SEC. 101. PERSON-CENTERED, TRAUMA-INFORMED CARE.**

6 Section 101(2) of the Older Americans Act of 1965
7 (42 U.S.C. 3001(2)) is amended by inserting “(including
8 access to person-centered, trauma-informed care)” after
9 “health”.

10 **SEC. 102. VACCINATION.**

11 Section 102(14) of the Older Americans Act of 1965
12 (42 U.S.C. 3002(14)) is amended—

13 (1) in subparagraph (B) by inserting “immuni-
14 zation status,” after “oral health,” and

1 (2) in subparagraph (D) by inserting “infec-
2 tious disease, and vaccine preventable disease,” after
3 “disease),”.

4 **SEC. 103. FUNCTIONS OF ASSISTANT SECRETARY.**

5 (a) REVIEW OF APPLICATIONS.— Section 202 of the
6 Older Americans Act of 1965 (42 U.S.C. 3012) is amend-
7 ed—

8 (1) by amending subsection (a)(4) to read as
9 follows:

10 “(4) administer the grants provided by this Act
11 but not approve an application submitted by an ap-
12 plicant for a grant for a program for which such ap-
13 plicant previously received a grant unless the Assist-
14 ant Secretary determines—

15 “(A) the program for which such applica-
16 tion was submitted is operating effectively to
17 achieve its stated purpose; and

18 “(B) such applicant complied with the as-
19 surances provided to the Assistant Secretary
20 with the application for such previous grant;
21 and”, and

22 (2) by adding at the end the following:

23 “(h) The Assistant Secretary shall publish, on an an-
24 nual basis, a list of centers and demonstration projects
25 funded under each title of the Act. The Assistant Sec-

1 retary shall ensure that this information is also directly
2 provided to States and area agencies on aging.”.

3 (b) ADDRESSING THE NEEDS OF OLDER INDIVID-
4 UALS IN DISASTERS.—Section 202(a) of the Older Ameri-
5 cans Act of 1965 (42 U.S.C. 3012(a)) is amended—

7 end,

8 (2) in paragraph (31) by striking the period at
9 the end and inserting “; and”, and

10 (3) by adding at the end the following:

11 “(32) provide technical assistance to and share
12 best practices with States and area agencies on
13 aging on how to collaborate and coordinate activities
14 and develop long-range emergency preparedness
15 plans with local and State emergency response agen-
16 cies, relief organizations, local and State govern-
17 ments, federal agencies as appropriate, and any
18 other institutions that have responsibility for dis-
19 aster relief service delivery.”.

20 **SEC. 104. PROFESSIONAL STANDARDS FOR NUTRITION OF-**
21 **FICIAL UNDER ASSISTANT SECRETARY.**

22 Section 205(a)(2)(C)(ii) of the Older Americans Act
23 of 1965 (42 U.S.C. 3016(a)(2)(C)(ii) is amended to read
24 as follows:

1 “(ii) be a registered dietitian or registered dieti-
2 tian nutritionist.”.

3 **SEC. 105. INTERAGENCY COORDINATING COMMITTEE ON**
4 **AGE-FRIENDLY COMMUNITIES.**

5 Section 203 of the Older Americans Act of 1965 (42
6 U.S.C. 3013) is amended—

7 (1) in subsection (b)—

8 (A) in paragraph (18) by striking “and” at
9 the end,

10 (B) in subparagraph (19) by striking the
11 period at the end, and inserting “, and”, and

12 (C) by adding at the end the following:

13 “(20) section 393D of the Public Health Serv-
14 ice Act (42 U.S.C. 280b–1f), relating to safety of
15 seniors.”, and

16 (2) in subsection (c)—

17 (A) in paragraph (1)—

18 (i) by striking “Aging” and inserting
19 “Age-Friendly Communities”, and

20 (ii) by inserting “to support the abil-
21 ity of older individuals to age in place, in-
22 cluding through the provision of homeless-
23 ness prevention services, support the abil-
24 ity of older individuals to access preventive
25 health care, promote age-friendly commu-

1 nities, and address the ability of older indi-
2 viduals to access long-term care supports,
3 including access to caregivers and home-
4 and community-based services” before the
5 period at the end,

6 (B) in paragraph (4) by inserting “, except
7 that the 1st term of a member appointed to the
8 Interagency Coordinating Committee on Age-
9 Friendly Communities shall begin not later
10 than 1 year after the effective date of this ex-
11 ception” before the period at the end,

12 (C) in paragraph (5) by striking “once
13 each year” and inserting “semiannually”,

14 (D) in paragraph (6)—

15 (i) in subparagraph (A)—

16 (I) in clause (iii) by striking
17 “and” at the end,

18 (II) in clause (iv) by adding
19 “and” at the end, and

20 (III) by adding at the end the
21 following:

22 “(v) identifying best practices for con-
23 necting older individuals to services for which
24 they may be eligible;”,

25 (ii) in subparagraph (B)—

1 (I) by inserting “transportation,”
2 after “housing,” the 1st place it ap-
3 pears,

4 (II) in clause (i) by striking
5 “and” at the end,

6 (III) by amending clause (ii) to
7 read as follows:

8 “(ii) innovations in technology applications
9 (including assistive technology devices and as-
10 sistive technology services) that—

11 “(I) promote safe and accessible inde-
12 pendent living environments; and

13 “(II) give older individuals access to
14 information on available services or help in
15 providing services to older individuals, in-
16 cluding information on transportation serv-
17 ices such as public transit, on-demand
18 transportation services, volunteer-based
19 transportation services, and other private
20 transportation services; and”, and

21 (IV) by adding at the end the fol-
22 lowing:

23 “(iii) transportation models that reduce
24 costs of transportation for older individuals and

1 provide the ability to schedule trips in advance
2 and on demand, as appropriate;”,

3 (iii) in subparagraph (E)—

4 (I) by striking “nongovernmental
5 experts and organizations, including
6 public health interest and research
7 groups and foundations” and insert-
8 ing “nongovernmental organizations,
9 academic or research institutions,
10 community-based organizations, and
11 philanthropic organizations”, and

12 (II) by striking “(F)” and insert-
13 ing “(G)”,

14 (iv) by redesignating subparagraphs
15 (E), (F), and (G) as subparagraphs (F),
16 (G), and (H), respectively,

17 (v) by inserting after subparagraph
18 (D) the following:

19 “(E) work with the Centers for Disease Control
20 and Prevention, the National Institute on Aging,
21 Centers for Medicare and Medicaid Services, the
22 Housing and Urban Development Office of Lead
23 Hazard Control and Healthy Homes, and other Fed-
24 eral agencies as appropriate, to develop rec-
25 ommendations, in accordance with paragraph (1), to

1 reduce falls among older individuals that incorporate
2 evidence-based falls prevention programs and home
3 modifications to reduce and prevent falls;”, and

4 (vi) by adding at the end the fol-
5 lowing:

6 “(9) In this subsection, the term ‘age-friendly com-
7 munity’ means a community that—

8 “(A) is taking steps—

9 “(i) to include accessible housing, acces-
10 sible spaces and buildings, safe and secure
11 paths, variable route transportation services,
12 and programs and services designed to maintain
13 health and well-being;

14 “(ii) to respect and include older individ-
15 uals in social opportunities, civic participation,
16 volunteerism, and employment; and

17 “(iii) to facilitate access to supportive serv-
18 ices for older individuals; and

19 “(B) has a plan in place to meet local needs for
20 housing, transportation, civic participation, social
21 connectedness, and accessible spaces.” and

22 (3) by adding at the end the following:

23 “(d) Not later than 2 years after the effective date
24 of this subsection, the Comptroller General of the United

1 States shall conduct a study and issue a report that in-
2 cludes—

3 “(1) an inventory of Federal programs, admin-
4 istered by the Department of Health and Human
5 Services, the Department of Housing and Urban De-
6 velopment, or any other Federal agency determined
7 appropriate by the Comptroller General, that sup-
8 port home assessments and home modifications for
9 older individuals and individuals with disabilities,

10 “(2) statistical data, for recent fiscal years, on
11 the number of older individuals and individuals with
12 disabilities served by each Federal program de-
13 scribed in paragraph (1) and the approximate
14 amount of Federal funding invested in each such
15 program,

16 “(3) a demographic analysis of individuals
17 served by each such program for recent fiscal years;

18 “(4) an analysis of duplication and gaps in pop-
19 ulations supported by the Federal programs de-
20 scribed in paragraph (1),

21 “(5) what is known about the impact of the
22 Federal programs described in paragraph (1) on
23 health status and health outcomes in populations
24 supported by such programs,

1 “(6) a review of Federal efforts to coordinate
2 Federal programs existing prior to the effective date
3 of this subsection that support home assessments
4 and home modifications for older individuals and in-
5 dividuals with disabilities and any considerations for
6 improving coordination, which may include an indi-
7 cation of the Federal agency or department that is
8 best suited to coordinate such Federal efforts, and

9 “(7) information on the extent to which con-
10 sumer-friendly resources, such as a brochure, are
11 available through the National Eldercare Locator
12 Service established under section 202(a)(21), are ac-
13 cessible to all area agencies on aging, and contain
14 information on home assessments and home modi-
15 fications for older individuals attempting to live
16 independently and safely in their homes and for the
17 caregivers of such individuals.”.

18 **SEC. 106. TECHNICAL ASSISTANCE ON AGE-FRIENDLY COM-**
19 **MUNITIES.**

20 Section 205(a)(2) of the Older Americans Act of
21 1965 (42 U.S.C. 3016(a)(2)) is amended—

22 (1) by redesignating subparagraph (C) as sub-
23 paragraph (D), and

24 (2) by inserting after subparagraph (B) the fol-
25 lowing:

1 “(C) The Assistant Secretary may provide technical
2 assistance, including through the regional offices of the
3 Administration, to State agencies, area agencies on aging,
4 local government agencies, or leaders in age-friendly com-
5 munities (as defined in section 203(c)(9)) regarding—

6 “(i) support for public and private entities in
7 building partnerships to promote such age-friendly
8 communities;

9 “(ii) dissemination of, or consideration of ways
10 to implement, best practices and recommendations
11 from the Interagency Coordinating Committee on
12 Age-Friendly Communities established under section
13 203(c); and

14 “(iii) methods for managing and coordinating
15 existing programs to meet the needs of growing age-
16 friendly communities.”.

17 **SEC. 107. MALNUTRITION.**

18 The Older Americans Act of 1965 (42 U.S.C. 2011
19 et seq.) is amended—

20 (1) in section 102(14)(B) by inserting “(includ-
21 ing screening for malnutrition)” before the semi-
22 colon at the end, and

23 (2) in section 330(1) by striking “and food in-
24 security” and inserting “, food insecurity, and mal-
25 nutrition”.

1 **SEC. 108. COORDINATION WITH RESOURCE CENTERS.**

2 (a) AREA PLANS.—Section 306(a) of the Older
3 Americans Act of 1965 (42 U.S.C. 3026(a)) is amended—

4 (1) in paragraph (16) by striking “and” at the
5 end,

6 (2) in paragraph (17) by striking the period at
7 the end and inserting “; and”, and

8 (3) by adding at the end the following:

9 “(18) provide assurances that the area agency
10 on aging will collect data to determine—

11 “(A) the services that are needed by older
12 individuals whose needs were the focus of all
13 centers funded under title IV in fiscal year
14 2019; and

15 “(B) the effectiveness of the programs,
16 policies, and services provided by such area
17 agency on aging in assisting such individuals;
18 and

19 “(19) provide assurances that the area agency
20 on aging will use outreach efforts that will identify
21 older individuals eligible for assistance under this
22 Act, with special emphasis on those older individuals
23 whose needs were the focus of all centers funded
24 under title IV in fiscal year 2019.”.

1 (b) STATE PLANS.—Section 307(a) of the Older
2 Americans Act of 1965 (42 U.S.C. 3027) is amended by
3 adding at the end the following:

4 “(31) The plan shall contain an assurance that
5 the State shall prepare and submit to the Assistant
6 Secretary annual reports that describe—

7 “(A) data collected to determine the serv-
8 ices that are needed by older individuals whose
9 needs were the focus of all centers funded
10 under title IV in fiscal year 2019;

11 “(B) data collected to determine the effec-
12 tiveness of the programs, policies, and services
13 provided by area agencies on aging in assisting
14 such individuals; and,

15 “(C) outreach efforts and other activities
16 carried out to satisfy the assurances described
17 in paragraphs (18) and (19) of section
18 306(a).”.

19 **SEC. 109. ARTS EDUCATION.**

20 (a) PROGRAM DESIGN.—Section 202(a)(5) of the
21 Older Americans Act of 1965 (42 U.S.C. 3012(a)(5)) is
22 amended by inserting “cultural experiences, activities and
23 services, including the arts,” after “education),”.

24 (b) SUPPORTIVE SERVICES.—Section 321(a)(7) of
25 the Older Americans Act of 1965 (42 U.S.C. 3030d(a)(7))

1 is amended by inserting “cultural experiences (including
2 the arts),” after “art therapy,”.

3 **SEC. 110. SOCIAL DETERMINANTS OF HEALTH.**

4 Section 301(a)(1) of the Older Americans Act of
5 1965 (42 U.S.C. 3021(a)(1)) is amended—

6 (1) in subparagraph (C) by striking “and” at
7 the end,

8 (2) in subparagraph (D) by striking the period
9 at the end and inserting “; and”, and

10 (3) by adding at the end the following:

11 “(E) address the social determinants of health
12 of older individuals.”.

13 **SEC. 111. FALLS PREVENTION AND CHRONIC DISEASE**
14 **SELF-MANAGEMENT EDUCATION.**

15 Section 411(a) of the Older Americans Act of 1965
16 (42 U.S.C. 3032(a)) is amended—

17 (1) by redesignating paragraphs (13) and (14)
18 as paragraphs (15) and (16), respectively, and

19 (2) by inserting after paragraph (12) the fol-
20 lowing:

21 “(13) bringing to scale and sustaining evidence-
22 based falls prevention programs that will reduce the
23 number of falls, fear of falling, and fall-related inju-
24 ries in older individuals and older individuals with
25 disabilities;

1 “(14) bringing to scale and sustaining evidence-
2 based chronic disease self-management programs
3 that empower older individuals and older individuals
4 with disabilities to better manage their chronic con-
5 ditions;”.

6 **SEC. 112. EXTENSION OF RAISE FAMILY CAREGIVERS ACT.**

7 Section 6 of the RAISE Family Caregivers Act (Pub-
8 lic Law 115–119; 132 Stat. 27) is amended by striking
9 “3” and inserting “4”.

10 **SEC. 113. SUPPORT FOR SOCIALLY-ISOLATED OLDER AMER-**
11 **ICANS.**

12 Section 102(14) of the Older Americans Act of 1965
13 (42 U.S.C. 3002(14)) is amended—

14 (1) in subparagraph (K) by striking “and” at
15 the end,

16 (2) in subparagraph (L) by striking “(K)” and
17 inserting “(L)”,

18 (3) by redesignating subparagraph (L) as sub-
19 paragraph (M), and

20 (4) by inserting after subparagraph (K) the fol-
21 lowing:

22 “(L) screening for the prevention of nega-
23 tive health effects associated with social isola-
24 tion and coordination of supportive services and

1 health care to address negative health effects
2 associated with social isolation; and”.

3 **SEC. 114. INCREASED FOCUS OF ASSISTANT SECRETARY ON**
4 **HEALTH EFFECTS ASSOCIATED WITH SOCIAL**
5 **ISOLATION.**

6 Section 202(a) of the Older Americans Act of 1965
7 (42 U.S.C. 3012(a)), as amended by section 103, is
8 amended—

9 (1) in paragraph (31) by striking “; and” and
10 inserting a semicolon,

11 (2) in paragraph (32) by striking the period at
12 the end and inserting “; and”, and

13 (3) by adding at the end the following:

14 “(33) develop objectives, priorities, and a long-
15 term plan for supporting State and local efforts in-
16 volving education about, prevention of, detection of,
17 and response to negative health effects associated
18 with social isolation among older individuals.”.

19 **SEC. 115. ADVISORY COUNCIL ON HEALTH EFFECTS ASSO-**
20 **CIATED WITH SOCIAL ISOLATION.**

21 Section 202 of the Older Americans Act of 1965 (42
22 U.S.C. 3012), as amended by section 103, is amended by
23 adding at the end the following:

24 “(i)(1) The Assistant Secretary shall convene an ad-
25 visory council on negative health effects associated with

1 social isolation with aging network stakeholders, including
2 caregivers, and select members in a manner that ensures
3 geographic diversity of the members—

4 “(A) to review and evaluate efforts to address
5 negative health effects associated with social isola-
6 tion among older individuals; and

7 “(B) to identify challenges, solutions, and best
8 practices related to such efforts.

9 “(2) The advisory council convened under paragraph
10 (1) shall—

11 “(A) ensure consideration of consumer-directed
12 care models; and

13 “(B) submit a report to Congress on its find-
14 ings.

15 “(3) The Federal Advisory Committee Act (5 U.S.C.
16 App.) shall not apply with respect to the advisory council
17 convened under paragraph (1).”

18 **SEC. 116. SUPPORTIVE SERVICES AND SENIOR CENTERS.**

19 Section 321(a) of the Older Americans Act of 1965
20 (42 U.S.C. 3030d(a)) is amended—

21 (1) in paragraph (24) by striking “and” at the
22 end,

23 (2) by redesignating paragraph (25) as para-
24 graph (26), and

1 (3) by inserting after paragraph (24) the fol-
2 lowing:

3 “(25) services that promote or support social
4 connectedness and reduce negative health effects as-
5 sociated with social isolation; and”.

6 **SEC. 117. DEMONSTRATION PROJECTS.**

7 (a) DEMONSTRATIONS.—Section 411(a) of the Older
8 Americans Act of 1965 (42 U.S.C. 3032(a)), as amended
9 by section 111, is amended—

10 (1) in paragraph (15) by striking “and” at the
11 end,

12 (2) by redesignating paragraph (16) as para-
13 graph (17), and

14 (3) by inserting after paragraph (15) the fol-
15 lowing:

16 “(16) projects that address negative health ef-
17 fects associated with social isolation among older
18 adults; and”.

19 (b) REPEAL.—Section 416 of the Older Americans
20 Act of 1965 (42 U.S.C. 3032e) is repealed.

21 **SEC. 118. YOUNGER ONSET ALZHEIMER’S DISEASE.**

22 (a) DEFINITION OF “FAMILY CAREGIVER”.—Section
23 302(3) of the Older Americans Act of 1965 (42 U.S.C.
24 3022(3)) is amended by inserting “of any age” after “an
25 individual”.

1 (b) DEFINITION OF “RESIDENT”.—Section 711(6) of
2 the Older Americans Act of 1965 (42 U.S.C. 3058(6)) is
3 amended by inserting “of any age” after “individual”.

4 **SEC. 119. PRIORITY FOR THE SENIOR COMMUNITY SERVICE**
5 **EMPLOYMENT PROGRAM.**

6 (a) PRIORITY.—The Older Americans Act of 1965
7 (42 U.S.C. 3001 et seq.) is amended—

8 (1) in section 503(a)(4)(C)—

9 (A) in clause (iii) by striking “and” at the
10 end,

11 (B) in clause (iv) by adding “and” at the
12 end, and

13 (C) by adding at the end the following:

14 “(v) eligible individuals who have been
15 incarcerated within the last 5 years or are
16 under supervision following the release
17 from prison or jail within the last 5
18 years;”,

19 (2) in section 514(e)(1) by inserting “older in-
20 dividuals who have been incarcerated or are under
21 supervision following the release from prison or jail,”
22 after “need,” and

23 (3) in section 518—

24 (A) in subsection (a)(3)(B)(ii)—

1 (i) in clause (IV) by striking “or” at
2 the end,

3 (ii) in clause (V) by striking the pe-
4 riod at the end and inserting “; or”, and

5 (iii) by adding at the end the fol-
6 lowing:

7 “(VI) have been incarcerated within
8 the last 5 years or are under supervision
9 following the release from prison or jail
10 within the last 5 years.”, and

11 (B) in subsection (b)(2)—

12 (i) in subparagraph (F) by striking
13 “or” at the end,

18 untary basis with the consent of the caregiver.”.

20 able to the aging network. Such information shall be
21 applicable to existing programs and help in the de-
22 velopment of new evidence-based programs and
23 interventions.

24 “(3) Activities of the Center shall include conducting,
25 promoting, coordinating, and providing support for—

1 “(A) research and evaluation activities that
2 support the objectives of this Act, including—

3 “(i) evaluation of new and existing pro-
4 grams and interventions authorized by this Act;
5 and

6 “(ii) research on and assessment of the re-
7 lationship between programs and interventions
8 under this Act and the health outcomes, social
9 determinants of health, quality of life, health
10 care savings (including to the Medicare pro-
11 gram under title XVIII of the Social Security
12 Act and the Medicaid program under title XIX
13 of such Act as practicable), and independence
14 of individuals served under this Act;

15 “(B) demonstration projects that support the
16 objectives of the Act and activities to bring effective
17 demonstration projects to scale with a prioritization
18 of projects that address the needs of underserved
19 populations;

20 “(C) outreach and dissemination of research
21 findings; and

22 “(D) technical assistance related to the activi-
23 ties described in this subparagraph.

1 “(4) The director shall be an individual with substan-
2 tial knowledge of and experience in aging and health pol-
3 icy, and research administration.

4 “(5) Not later than October 1, 2020, and at 5-year
5 intervals thereafter, the director shall prepare and publish
6 in the Federal Register for public comment a draft of a
7 5-year plan that—

8 “(A) outlines priorities for research, research
9 dissemination, evaluation, and related activities;

10 “(B) explains the basis for such priorities; and

11 “(C) describes how the plan will meet the needs
12 of underserved populations.

13 “(6) The director shall coordinate research, research
14 dissemination, evaluation, and demonstration projects,
15 and related activities with appropriate agency program
16 staff, and, as appropriate, coordinate with other Federal
17 departments and agencies involved in research in the field
18 of aging.

19 “(7) Not later than December 31, 2020, and annually
20 thereafter, the director shall prepare, and submit to the

2 older individuals;

4 “(F) support for older relative caregivers

7 ative caregivers (as defined in section 372)
8 raising children (such as kinship navigator
9 programs); or

10 “(ii) involving volunteers who are
11 older individuals who provide support and
12 information to families who have a child
13 with a disability or chronic illness, or other
14 families in need of such family support;

15 “(2) to coordinate multigenerational activities
16 and civic engagement activities, including
17 multigenerational nutrition and meal service pro-
18 grams;

19 “(3) to promote volunteerism, including becom-

17 Medicare & Medicaid Services.

22 such Principles.

23 (b) DISSEMINATION.—The Administrator shall dis-
24 seminate the principles to appropriate stakeholders within

2 use the principles in setting priorities for service delivery
3 and care plans in programs carried out by the agencies.
